Now in compliance to the instructions and in accordance with the procedure and schedule for the said elections prescribed by the Hon'ble Returning Officer, the undersigned requests every affiliated unit of BAI to intimate the name(s) of their representative(s) / delegate(s), so as to reach the undersigned latest by 13th June 2011. Such intimation should be addressed to the Hony. General Secretary, BAI on their letter head duly signed by the Secretary General / Secretary of the Member unit.

The nomination of the name(s) of the representative(s) / delegate(s) so intimated should be in accordance with the relevant Clause 13.4 of the Memorandum of Association of the Badminton Association of India, which provides that each affiliated unit which has conducted a National Championships shall be entitled to nominate two delegates and the others, one delegate each to represent it at every General meeting. The said Clause further provides that such delegates shall either be the office bearers or
