- To consider the proposal of Mr. K.C. Punnaiah Choudary (A.P.) and Shri H. Gyaneswor Singh (Manipur) and Shri Arvind Singhal (Rajasthan);
- 13. Any other matter with the permission of the Chair.

In addition to above, the detailed programme for the elections of the President and the Treasurer, BAI shall be advised separately as soon as the same is declared by Hon'ble Mr. Justice A. N. Gupta, a retired High Court Judge, who has been appointed as the Returning Officer in accordance with the latest Government directives. In order to ensure the best possible standards of fairness and transparency during the entire election process Hon'ble Mr. K.S. Ojha, a retired District Judge has been appointed as the Assistant Returning Officer for the said elections. Observers from the Ministry of Youth Affairs and Sports, Government of India, Indian Olympic Association, Commissioner and I.G., Registration and Stamps, Govt. of Andhra Pradesh etc. would also be invited to observe the said elections.

Note: The Agenda No. 1 i.e. the elections for the posts of the President and the Treasurer, BAI would be taken up first and during the said Agenda AGM will be presided over by the Chairman, BAI. After the results of the said elections are declared by the Returning Officer, the newly elected President would take the charge, preside over the Chair and then only the remaining Agendas would be taken up for discussion.
