Sri Sekhar C. Biswas, Vice President, BAI proposed the name of Dr. O. D. Sharma which was seconded by Sri Mayur Parikh, Jt. Secretary, BAI.

Thereafter, Dr. O. D. Sharma took the Chair.

Fifty Four (54) delegates from Affiliated Units had attended the meeting as per list enclosed.

Sindhu became the first women player from India to win two individual medals from Olympic Games. He also mentioned during the year 2020-21 Indian Players have won 106 Medals in
