Sub: Conduct of Inter Institutional Championships 2026.

Dear All,

Please note that the Yonex-Sunrise All India Inter Institutional Badminton Team and Individual Championships-2026 will be held from 28th June to 1st July 2026 at iSportz Badminton Arena , Raipur , Chhattisgarh.

As per BAI Circular issued on 3rd July 2024, ONLY permanent employees of the institutions are eligible to participate in the tournament.

In addition to the above, per the decision made at the BAI AGM on 31st May 2025, and confirmed in the letter dated 20th June 2025, contract players of the Airports Authority of India (AAI) are allowed to participate in the Inter-Institutional Individual & Team Championship with immediate effect.

The eligibility criteria mentioned below must be strictly followed for participation:

A. Individual Championship

Contracted players with a minimum of 6 months of completed service are eligible to participate. These players should have 3 years contract.

B. Team Championship (Both conditions must be met)

- Players must hold a minimum 3-year contract and have completed at least 18 months of service.
- Players must have completed 18 years of age on the start date of the tournament.

1. The system of "Men Team Championships & Women Team Championships will be held as under.

A. Team Event (Men). (Total 5 matches)

A. Team Event (Women). (Total 5 matches)

First Singles
Second Singles
First Doubles
Third Singles
Second Doubles.

The results of each tie will be on a best of 5 matches in Men's' & Women's' categories respectively.

- a) The draw will take place during the Managers' Meeting, at the Venue" before the commencement of the Championships.
- b) Individual Events will also be held after Team Championships. Each participating Team is eligible for two (2) Singles, One (1) Doubles and One (1) Mixed Doubles. Individual Draw will take place at the venue after team events
- c) Each Team is eligible to send Minimum Six (6) not more than Ten (10) in Men Team & Minimum Six (6) not more than Ten (10) Women Team (Extra Players not permitted) + Coach and Manager.
- d) For individual events, players to be selected from the above team members only. (Extra players are not eligible). Seeding as per the BAI ranking or by previous performance or by lot.
3. No player shall play in more than two events in both Team & Individual Events.
4. Each competing Associated Member is responsible for determining the criteria and method of selecting players for to represent its Association.
5. Each Manager in the Managers' meeting shall submit 5 singles and 4 doubles pairs in order of strength for Mens' & Womens' team championship. The same ranking order shall be valid for all ties in the competition.
6. In normal cases, substitution of player/pair is not permitted once the team is nominated for the competition. However, the Referee will have the authority to accept changes for unavoidable and genuine cases.
7. Merit Certificates shall be presented to the 1st , 2nd & 3rd places (Loosing semi-finalists). Participation certificates shall be issued to the other players, those not received Merit Certificates.

NOMINATION OF TEAMS FOR A TIE

- Respective managers shall hand over the nomination for a tie to the Referee during managers' meeting.

- No player shall be allowed to participate in more than one singles and one doubles match in the same tie.
- Play in each tie shall be stopped when the tie is decided. (3 matches).
- A player who withdraws from the singles event of a tie can participate in the doubles event of the same tie.
- Any change of sequence in order of players is acceptable 2 hrs prior to the commencement of the tie, in writing.
- The referee shall inform such changes to the opponent team at the earliest. (before one hour)
- Players withdrawn in one tie is permitted to play in the next tie.
- Any player participating in two matches is entitled to a minimum interval of 20 minutes between them.
- The seeding for Individual event draw will take place as per BAI ranking. In case of non-availability of BAI ranked players, the Referee will decide seeding by previous year results or by lots in presence of Organizers.

The finalists (Both winners and runner up) in all individual events are eligible to participate in Senior Nationals. Winners of the team event are eligible to participate in Team Championships in the Senior Nationals.

The Winners and Runner up of Team events are eligible to send 2 Singles and One Doubles and One Mixed Doubles in the Main Draw of Senior Nationals besides winner & runner up in individual events.

The Member Associations of Institutional teams are requested to send a Demand Draft of Rs:10,000/- (Ten thousand) in favour of Badminton Association of India payable at Delhi towards Annual fee, before participation, if not already paid.
